

"Winnipeg Blue Bombers 2024 Home Game #6 Ticket Giveaway"

Rules & Regulations

- 1. **CONTEST TIMING:** The Winnipeg Blue Bombers 2024 Home Game 6 Ticket Giveaway (the "Contest") runs from 9:00:01 a.m. Mountain Time ("CT") on July 12th 2024 (the "Contest Start Date"), through to 12:00 p.m. CT on July 29th, 2024 (the "Contest Closing Date") (the period between the Contest Start Date and the Contest Closing Date being the "Contest Period").
- 2. **ELIGIBILITY:** The Contest is open to legal residents of Manitoba who have reached the age of majority as of the Contest Start Date. Notwithstanding the foregoing, the Contest is not open to any person who is an employee, officer or director of Reliance Comfort Limited Partnership (the "Sponsor"), the Canadian Football League or any of its member teams (collectively "CFL"), or of any agent, representative, partner, affiliate, subsidiary, parent or related company or advertising or promotional agency of the Sponsor or of the CFL or who is a member of the immediate family (i.e. parent, sibling, child or spouse) or household of any of the above persons.

The Sponsor shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification.

All personal and other information requested by and supplied to the Sponsor for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsor reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

One entry per person. Use of multiple email addresses or phone numbers by one entrant to enter more times than permitted by these rules is prohibited and all entries submitted by such entrant will be disqualified.

- 3. **HOW TO ENTER:** No purchase is necessary to enter the Contest. To enter, visit the Reliance's contest website at the following link: https://www.reliancehomecomfort.com/GoBlue during the Contest Period, and complete the contest form.
- 4. **PRIZES:** There are (2) prizes available to be won, each consisting of (2) tickets to the Winnipeg Blue Bombers home game on August 1st, 2024 (the "Prize") at 315 Chancellor Matheson Rd, Winnipeg MB. Approximate retail value of the Prize is \$350 CAD. The Prize is non-transferable and must be accepted as awarded. All costs not specifically identified as being included in the Prize are the responsibility of the winner. If the Prize is forfeited, then it will not be redrawn and offered to any other entrant unless the Sponsor decides to do so in its sole discretion.

Each confirmed Prize winner and their guest acknowledge and accept all risk of damages, injury or other loss incidental to any game for which tickets are issued, whether occurring before, during or after the game, and hereby voluntarily agree to assume the same. The Sponsor and the CFL reserve the right to refuse admission and/or to expel from the game, any person whose conduct is deemed by them to be objectionable. Expulsion from the game cancels the tickets for the offending individual(s) and the individual(s) thereupon forfeit(s) all claims with respect to the tickets. Participation in the Prize is subject to compliance with all applicable laws, by-laws, regulations; failure to comply may result in non-admission or expulsion from further participation in the Prize.



- 5. **DRAW:** A random draw for 2 winners (the "Draw") will be held by the Sponsor on July 29th, 2024 at approximately 3:00 p.m. EST in Toronto, Ontario, from all eligible entries received by the Contest Closing Date. The odds of being selected in the Draw depend on the total number of eligible entries received by the Contest Closing Date.
- 6. **CONSENT TO USE PERSONAL INFORMATION:** The Sponsor respects your right to privacy. The information provided to enter the Contest will be used for the purpose of administering the Contest, Prize fulfillment. - 7. **SELECTED ENTRANT:** The Sponsor will make reasonable efforts to contact each selected entrant by their provided phone number and/or email address. If a selected entrant cannot be contacted or does not respond to the Sponsor's attempts at contact, within 24 hours of Sponsor's first attempted notification, the selected entrant will be disqualified and Sponsor reserves the right to select an alternative entrant from remaining eligible entries, time permitting.

In order to be declared a winner of the Prize, the selected entrant will be required to: (a) correctly answer a time-limited skill-testing mathematical question; and (b) sign a declaration and release form provided by the Sponsor certifying compliance with these rules and releasing the Sponsor and its agents, representatives, partners, affiliates, subsidiaries, parent and related companies, advertising and the promotional agencies, and all of their respective directors, officers, owners, employees, agents, representatives, successors and assigns (collectively, the "Releasees") from any liability in connection with the Contest or the Prize.

The declaration and release documents must be returned to the Sponsor by no later than 12:00 pm EST on July 30th, 2024. If the completed declaration and release documents are not returned within the time specified, or if the selected entrant fails to correctly answer the skill-testing question in the manner prescribed or otherwise fails to comply with these Rules, the Prize will be forfeited and may not be drawn for again. By accepting a Prize, a winner consents to the use of his/her name, city/province of residence, voice, statement and photograph or other likeness for any publicity by the Sponsor, without further compensation.

Persons (or the parents/legal guardians of any legal minors) attending as guests of the winner may also be required to complete and return a liability and publicity release before the Prize will be awarded.

- 8. **RELEASEES NOT LIABLE:** Entrants agree that the Releasees are not responsible for any incorrect or inaccurate transcription of entry information, or for any human error, technical malfunctions, lost/delayed data transmission, omission, interruption, deletion, defect, failures of any mail, courier or postal service, communication line or network, computer equipment, software, inability to access any website (including the Contest Website) or online service, or any other error or malfunction. The Releasees shall not be responsible for any damage to or arising from any person's participation in the Prize, including without limitation any damage sustained at the game or during any game related activities.
- 9. **RIGHTS AND REGULATIONS:** Sponsor reserves the right to cancel, terminate, modify, or suspend the Contest at any time without notice to the entrants. Sponsor reserves the right to disqualify any entrant that tampers with the operation of the Contest or violates the rules of the Contest. All decisions of Sponsor are final and binding in all matters relating to the Contest. The Contest is subject to all applicable federal, provincial and municipal laws and regulations.
